RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT.

In consideration of being granted the benefits and privilege of Membership by the Waterloo Regional Kart Club; I the undersigned, for myself, my personal representatives, heirs, next of kin, successors and assigns,

Do:

a. Hereby agree to assume all responsibility and liability for all acts or activities of myself, my drivers, assistants and crew for any and all damage or injury that may be caused by any or all of us by our kart, motor, properties or possessions in any way growing out of or resulting from the operation of our equipment and/or as a result of our participating in a WRKC event or practice during the actual sanctioned and licensed period.

b. Hereby agree to be bound by the rules of the Waterloo Regional Kart Club that decisions of its officials and/or interpretation of the applicable competition rules will be governed exclusively by the administrative review and appeal procedure in these WRKC's Rules and Regulations.

c. Hereby release, waiver discharge and covenant not to sue the WRKC, including all its corporate, elected and appointed officials, all members of committees referees and inspectors, its individual members, **any race track hired for the use of WRKC**, KW Oktoberfest Inc., agencies of government which control essential land sites, financiers and firms which render essential service gratis, including all officers, agents and employees of the foregoing and volunteer workers assisting in Waterloo Regional Kart Club race, practice, training event or social event, all hereinafter referred to a "Releases" from or for any and all liability to me, my personal representatives heirs, next of kin, successors, and assigns for all loss of damage for bodily injury, death or damage to property of the undersigned which in any way grows out of our results from any WRKC race or practice activity or part thereof, during the actual period and whether any such claim may be based upon alleged active or passive negligence whether caused by he release or otherwise, or participation in the wrong, or upon any alleged breach of any statutory duty or obligation and

d. Hereby agree to indemnify and save and hold harmless the releases and each of them from any loss liability damage or cost they may incur due to the presence of the undersigned in our upon the restricted area or in any way competing officiating, observing or working of r, any purpose participating in the event and whether caused by negligence of the releases or otherwise

e. Hereby assume full responsibility of and risk of bodily injury, death or property damage due to the negligence of releases or otherwise while in or upon the restricted area and/or while completing, officiating observing, or working for or for any purpose participating in any event, organized by the Waterloo Regional Kart Club.

f. The undersigned expressly acknowledges and agrees that the kart racing is very dangerous and involves the risk of serious injury and/or death an/or property damage, the undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be a broad and inclusive as is permitted by the law of the Province in which any event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

g. Hereby agree that the WRKC or its assigns, on a non-exclusive; basis may use my name and pictures including pictures of my racing equipment, taken at any event for publicity purposes.

Zero Tolerance Policy for Physical and Verbal Abuse Waterloo Regional Kart Club

The mission of the Waterloo Regional Kart Club is to provide a safe, fair, positive and respectful environment where all drivers, families, officials and spectators can enjoy the sport of racing.

The racetrack must be free of negative factors, such as abuse, discrimination, intimidation, hateful words and deeds, and physical violence in any form.

The Waterloo Regional Kart Club will not tolerate:

- Violence of any kind
- Harmful, threatening or actual acts of violence
- Verbal abuse of any form
- Any activity which places the safety of drivers, officials or spectators at risk of personal injury

The Waterloo Regional Kart Club Executive will ensure that:

- All members of the Waterloo Regional Kart Club receive a copy of the “Zero Tolerance Policy”
- Officials respond appropriately, without delay and in a consistent fashion when dealing with an incident
- There are serious consequences for any individual who is in violation with this policy, including, but not limited to:
 - **Disqualification** for a **heat** resulting in **zero points** for the **heat**
 - **Disqualification** for the **race day** resulting in a **DQ**, which cannot be dropped from seasons points, for the **race day**
 - **Suspension** from the **next race day**
 - **Expulsion** from the **Waterloo Regional Kart Club** for the remainder of the **season**
- Repeat offenders will be dealt with more severely and violation with this policy may result in permanent expulsion from the Waterloo Regional Kart Club.

The purpose of this policy is to:

- Reduce the incidents of verbal and physical abuse
- Provide opportunities for officials to develop the skills necessary to handle incidents of verbal and physical abuse in a consistent manner
- Promote long-term prevention of verbal and physical abuse, and violence by preparing individuals to manage themselves in non-abusive way

Waterloo Regional Kart Club begins the 2012 racing season with this zero tolerance policy. As a member, official or individual associated with the Waterloo Regional Kart Club we expect you to do your part and set the example by complying with this policy.



2012 Drivers and Parents Pledge

I recognize that every member of the Waterloo Regional Kart Club has the right to race in a safe and pleasant environment. To this end:

- ⌘ I will promote good sportsmanship both on and off the racetrack
- ⌘ I will be in control of all my actions both on and off the racetrack, at all times during a race day.
- ⌘ I will contribute to the operation of the club and or race day events.
- ⌘ I will positively promote the Waterloo Regional Kart Club throughout the racing community
- ⌘ I understand that verbal and/or physical abuse of another driver, parent, or race official could result in severe consequences.
- ⌘ I have read and understand the Zero Tolerance Policy for Physical and Verbal Abuse.

1. _____ before race preparation team

Includes sweeping and blowing track, moving sites, set-up transponder scoring tent; set out pylons, fire extinguishers, scales, flags, microphone and loud speakers; line up board etc. Approximately 6:30 am to 7:00 am

2. _____ after race Clean up team

Includes putting away scales, flags, pylons, fire extinguishers, and transponder scoring tent, microphone and loudspeaker, replacing tires around track. Approximately 1:00 pm to 1:30 pm

3. _____ Pre-tech team

4. _____ Motor Painting Team

5. _____ Scales Marshall Team

Monitor karts as they cross the scales and notify scorers of underweight karts.

6. _____ Computer/Transponder Scoring Team

People who will take charge of the transponders-make sure that they are charged, then distribute & collect them on race day.

7. _____ Manual Scoring Team

People to call kart numbers as they cross the start/finish line and people to write the numbers on lap sheets as they are called. Also needed are "spotters" who watch for lapped karts, identify accident karts, and keep the flagman informed of lap numbers.

8. _____ Special Events Team

Help plan and run barbeque and mini-golf day, corn roast, Oktoberfest, banquet etc.

9. _____ Media Liaison

Send race results, photos etc. to Inside Track, PRN, newspaper etc.

10. _____ Newsletter Team

Help produce WRKC newsletter

Medical Self-Declaration for a Competition Licence

ASN Canada FIA reserves the right to request a medical examination by a physician from a licence applicant at any time. Drivers shall not participate in any competition unless they meet, and continue to meet, the medical requirements of the competition licence as stated in the ASN Canada FIA Karting Regulations Book 1.

Applicants up to age 50

At the time of application for a competition licence, drivers shall submit a completed and signed Medical Self Declaration form. If the applicant is under the age of majority in the province of application the Medical Self Declaration must also be signed by a Parent/Guardian.

Applicants 50 and older

All Licence applicants 50 years of age and older are required every two years to pass a medical examination by a physician.

Applicants for International grades of Competition Licence

Applicants are required to pass an annual medical examination. International licence applicants 45 years of age and over must pass a stress-related electrocardiogram test initially and every 2 years thereafter.

In full or partial consideration for allowing my minor child/ward to participate in all related activities of the **EVENT**,
I hereby warrant and agree that:

1. I am the parent/guardian having full legal responsibility for decisions regarding my minor child/ward,

namely _____; and

2. I am familiar with and accept, on behalf of myself and my minor child/ward, that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
3. I have satisfied myself and believe that my minor child/ward is physically, emotionally and mentally able to participate in this **EVENT**, and that his/her protective clothing, gear and equipment is fit and appropriate for his/her use in this **EVENT**; and
4. I understand, and will instruct my minor child/ward, that regardless of his/her role, all applicable rules for participation must be followed and that at all times the sole responsibility for personal safety remains with my minor child/ward; and
5. I will immediately remove my minor child/ward from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that my minor child/ward has experienced any deterioration in his/her physical, emotional or mental fitness, or that of his/her protective clothing, gear or equipment, for continued safe participation in the **EVENT**.

I UNDERSTAND AND AGREE, ON BEHALF OF MY MINOR CHILD/WARD, HIS/HER HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

1. AN UNQUALIFIED ASSUMPTION OF ALL RISKS associated with participation in the **EVENT** by my minor child/ward even if arising from negligence or gross negligence, including any compounding or aggravation of injuries caused by negligent rescue operations or procedures, of the event organizer, the event venue(s) and of any persons associated therewith or participating therein; and
2. A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have or may in the future have against any person(s), entities, or organization(s) associated in any way with the **EVENT** including the track owners and lessees, promoters, sanctioning bodies, racing associations, or any subdivision thereof, track operators, sponsors, advertisers, vehicle owners and other participants, rescue personnel, event inspectors, underwriters, consultants, and others who give recommendations, directions or instructions, or engage in risk evaluation and loss control activities, regarding the **EVENT** or event premises, or any one or more of them, and their respective directors, officers, employees, contractors, agents and representatives (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that my minor child/ward may suffer, or that his/her next of kin may suffer as a result of his/her use of or presence at the event facilities or my child's/ward's participation in any part of, or presence at, the **EVENT**, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE RELEVANT OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES; and
